## **Official Rules for Destination Panama City Sweepstakes**

**OFFICIAL RULES:** By participating, entrants agree to be bound by these Official Rules and by the decisions of Sponsor, which shall be binding and final as to all matters related to the Sweepstakes. The Sweepstakes is subject to all applicable federal, state and local laws.
