2018 TERMS AND CONDITIONS

Destination Panama City, the owner and promoter of “**ONE HARRISON FOOD + WINE FESTIVAL**” agrees to reserve a space for the Company’s use in the **ONE HARRISON FOOD + WINE FESTIVAL** in Panama City, Florida, on November 2 & 3, 2018. Signature and payment constitutes the Company’s agreement to abide by the cancellation policy and all other rules and policies stated in the registration fact sheet. Registration and booth space will not be confirmed until payment is received.

I also understand that my company/company representatives may be filmed and photographed during the event and I give Destination Panama City permission to do so and grant to Destination Panama City the absolute and irrevocable right and unrestricted permission concerning any photographs, video footage or other likeness (collectively, “photography”). I understand that all photography is the property of Destination Panama City and agree that I/my company will not receive any compensation for the use of any photography acquired during the **ONE HARRISON FOOD + WINE FESTIVAL**. Destination Panama City reserves the right to use all recipes, photography, and biographies the Company in promotional materials including, but not limited to, the official website, advertising and marketing collateral, to use, reuse, publish, and republish the photography in whole or in part, individually or in connection with other material, in any and all media now or hereafter known, including the internet, and for any purpose whatsoever, specifically including illustration, promotion, art, editorial, advertising, and trade, without restriction as to alteration; and to use my name/ company name in connection with any use Destination Panama City so chooses.

The Company releases and discharges the Destination Panama City from any and all claims and demands that may arise out of or in connection with the use of the photography, biographies, or recipes, including without limitation any and all claims for libel or violation of any right of publicity or privacy. This authorization and release shall also inure to the benefit of the employees, agents, successors, assigns and licensees of Destination Panama City. All wine, beer, spirits, and/or food is donated and you are responsible for the security, transport and proper handling and storage of your product, consistent with all local, state and federal ordinances, rules, regulations and statutes.

INSURANCE: The Company shall maintain Comprehensive General Liability Insurance and Personal Injury coverage for all of the Company's activities at the show, all at the Company's sole cost and expense. Policy limits shall be at least \$1,000,000/\$1,000,000 Bodily Injury and Property Damage combined. The Company shall also maintain, at their sole cost and expense, Workers Compensation Insurance for employees participating in the **ONE HARRISON FOOD + WINE FESTIVAL**. Evidence of insurance coverage in the form of a valid Certificate of Insurance specifying that coverage include activities at the show must be provided to Destination Panama City prior to move-in. The Company warrants that it has and shall have insurance complying with these insurance requirements and with such other requirements as may be promulgated by Destination Panama City for **ONE HARRISON FOOD + WINE FESTIVAL**.
