2022 4th of July Celebration Vendor Registration Policies:

- ❖ Vendor availability is based on a first come, first served basis.
 - No spots are held without pre-payment.
- ❖ Vendors must comply with all Local, State, and Federal tax and revenue reporting.
- ❖ Vendor position is at the sole discretion of Destination Panama City.
- ❖ Vendors must maintain a clean space and ensure their area is completely clean upon departure.
- ❖ Vendors must adhere to all Panama City, Bay County, State of Florida, and Federal laws / regulations.
- ❖ Destination Panama City has the right to cancel any vendor contract at any time for any reason with a full refund to the Vendor.
- ❖ Vendors have the right to withdraw their application up to 48 hours before the event for a full refund. Any no shows or cancellations within 48 hours will forfeit the application fees.
- ❖ Vendors may not transfer their application, fee payment, or position to another Vendor.
- ❖ Food vendors must put down necessary protection when using hot grease. Vendors using hot oil must submit a grease disposal plan with application.
- ❖ **Set up Time is 10AM, July 4, 2022 and MUST BE COMPLETE by 1PM.**
- ❖ Expedient loading and unloading **is required and at no time may a vendor block an egress for more than 5 minutes.**
- ❖ Vendor parking is first come first served.
- ❖ Vendor space boundaries are strictly enforced.
- ❖ Vendors must bring all essential materials for vending – tables, chairs, lights, tents, etc.
 - Table, tent, and chair rental may be booked with DMC Rentals, via Joey Capo, separately.
- ❖ Food Vendors must comply with State of Florida – Hotels & Restaurants Division laws and regulations for vendor. Questions regarding this – call 850.487.1395
- ❖ Vendors must remit their Resale Certificate, Insurance, Tax ID Number, and payment at time of application.
- ❖ Vendors must remain open the duration of the event. **Festival Hours: 2PM – 10PM, Monday, July 4, 2022**
- ❖ Vendors will not be permitted to sell items with obscene, abusive, derogatory language or images.
